1. Enw'r Gorchymyn hwn yw Gorchymyn Cynulliad Cenedlaethol Cymru (Cymhwysedd Deddfwriaethol) 2007 ac fe ddaw i rym drannoeth diwrnod ei wneud.

#### **Diwygio Atodlen 5 i Ddeddf Llywodraeth Cymru 2006**

2.—(1) Mae Maes 20 (y Gymraeg) o Ran 1 o Atodlen 5 i Ddeddf Llywodraeth Cymru 2006 wedi ei ddiwygio yn unol â'r erthygl hon.

(2) Ar ôl "Field 20: Welsh language" mewnosoder—

*"Matter 20.1*

Provision for and in connection with the Welsh language, being the native language of Wales, to –

- (a) be an official language in Wales;
- (b) give to the people of Wales the right to receive services through the medium of Welsh, to work through the medium of Welsh and to learn Welsh;
- (c) establish a Language Commissioner for Wales; and
- (d) establish a Welsh Language Council.”

Mae'r gorchymyn hwn yn diwygio Atodlen 5 i Ddeddf Llywodraeth Cymru 2006 ("Deddf 2006"). Effaith y gorchymyn yw estyn cymhwysedd deddfwriaethol Cynulliad Cenedlaethol Cymru i wneud deddfau newydd i Gymru drwy gyfrwng Mesurau o dan adran 93 o Ddeddf 2006.

Mae Erthygl 2 yn mewnosod mater newydd 20.1 ym maes 5 o Ran 1 o Atodlen 5 i Ddeddf 2006. Mae'r mater newydd ynghylch datgan y Gymraeg yn iaith swyddogol yng Nghymru, rhoi hawliau i bobl Cymru i gael gwasanaethau drwy gyfrwng y Gymraeg, hawliau i allu gweithio drwy gyfrwng y Gymraeg, a hawliau i ddysgu'r Gymraeg, sefydlu Comisiynydd Iaith i Gymru a sefydlu Cyngor yr Iaith Gymraeg. Bydd unrhyw ddarpariaeth mewn Mesur Cynulliadol sy'n ymwneud â mater newydd 20.1 o fewn cymhwysedd deddfwriaethol y Cynulliad yn rhinwedd telerau'r mater hwnnw ac adran 94(4) o Ddeddf 2006.

In accordance with section 95(5) of the Government of Wales Act 2006(a) a draft of this order has been laid before the National Assembly for Wales and Parliament and approved by the Assembly and each House of Parliament.

Accordingly, Her Majesty, in pursuance of section 95(1) of the Government of Wales Act 2006, is pleased, by and with the advice of Her Privy Council, to order as follows:-

**Citation and commencement**

1. This Order may be cited as the National Assembly for Wales (Legislative Competence) Order X 2007 and it comes into force on the day after the day on which it is made.

**Amendments to Schedule 5 to the Government of Wales Act 2006**

2.—(1) Field 20 (Welsh language) of Part 1 of Schedule 5 to the Government of Wales Act 2006 is amended in accordance with this article.

(2) After “Field 20: Welsh language” insert—

*“Matter 20.1*

Provision for and in connection with the Welsh language, being the native language of Wales, to –

(a) be an official language in Wales;

- (b) give to the people of Wales the right to receive services through the medium of Welsh, to work through the medium of Welsh and to learn Welsh;
- (c) establish a Language Commissioner for Wales; and
- (d) establish a Welsh Language Council.”

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This order amends Schedule 5 to the Government of Wales Act 2006 (“the 2006 Act”). The effect of the order is to extend the legislative competence of the National Assembly of Wales to make new laws for Wales by Measure under section 93 of the 2006 Act.

Article 2 inserts a new matter 20.1 into field 5 of Part 1 of Schedule 5 to the 2006 Act. The new matter is about declaring Welsh an official language in Wales, giving rights to the people of Wales to receive services through the medium of Welsh, to be able to work through the medium of Welsh and to learn Welsh, to establish a Language Commissioner for Wales and to establish a Welsh Language Council . Any provision of an Assembly Measure relating to the new matter 20.1 will be within the legislative competence of the Assembly by virtue of the terms of that matter and section 94(4) of the 2006 Act.
